| 1) The participant declares under his / her own responsibility to be in good health (especially not suffering from asthma, cardio-vascular problems or hypertension) and in good physical condition, with no impediments to do the excursion that take place in a volcanic environment, to be equipped with the necessary gear suitable for the type of excursion that he/she intends to take part and listed in the confirmation and to exempt the licensed volcanological guide and the "Cooperative Society of Etna Nord Volcanological Guides" of any liability whether civil or criminal relative to and resulting from the excursion. |
| 2) The Participant agrees to behave in accordance with legal and civil rules during the excursion and not to engage in, under any circumstances, behavior that might endanger their own or others' safety. He/she agrees to comply with the directions code of behavior that is provided by the licensed volcanological guides, and technical decisions related to safety considerations including decisions on any change of route, duration of the excursion or even cancellation and not to take initiatives that are not shared or authorized by the guides. |
| 3) The Participant agrees to compensate for any damage to property or materials belonging to the organization, caused by his/her own carelessness and/or negligence. |
| 4) The Participant, by signing this form, releases the licensed volcanological guide and the "Cooperative Society of Etna Nord Volcanological Guides" from any civil and criminal liability, whatsoever, as a result of injuries caused to him or her or others and illness during the entire duration of the excursion, or resulting from the use of equipment. The Participant also releases the guides and the "Cooperative Society of Etna Nord Volcanological Guides" of any liability related to theft and / or damage of any personal item. |
